MEET THE KEYNOTE SPEAKER



Raymond M. Brown is a partner at Pashman, Stein, Walder Hayden. He concentrates his practice in white-collar crime, complex civil litigation, internal investigations, corporate compliance and international criminal matters (transactional, humanitarian and human rights.)

Mr. Brown has been a trial lawyer, teacher and legal journalist since 1974. He is a Fellow of the American College of Trial Lawyers and of the American Board of Criminal Lawyers. He is a past president of the Association of Criminal Defense Lawyers of New Jersey and former Board Member and Parliamentarian of the National Association of Criminal Defense Lawyers.

He was for 20 years the Host of the Emmy Award-winning New Jersey Network Program "Due Process" and has provided legal analysis in many broadcast venues. Brown has taught International Criminal Law (ICL) in the Seton Hall/American University Program at Cairo, Egypt and at Seton Hall University's School of Diplomacy and International Relations where he has also taught Peacekeeping and Peacemaking and International Human Rights Law and Policy. Brown has also taught Criminal Law, Criminal Procedure, Professional Responsibility and Advanced Criminal Procedure and a Death Penalty Seminar.

He has spoken in more than 30 states and multiple foreign jurisdictions to criminal and civil lawyers, law enforcement personnel and judges, diplomats, students and a variety of civil society organizations on trial advocacy, ethics, race, human rights and international law, the art of persuasion, and educational policy. He has also written widely on these subjects. Brown has received numerous professional awards including the 2021 Daniel J. O'Hern Award of the N.J. Commission. On Professionalism in the Law and 2022 the Medal of Honor of the New Jersey Bar Foundation.

Mr. Brown is a graduate of Columbia University and received his law degree from The School of Law, University of California, Berkeley.
